1. Introduction

Hello and welcome. This website is owned and operated by The Natural Fox, LLC, a Colorado limited liability company ("The Natural Fox," "we," "us," or "our"). By visiting our website and accessing the information, resources, services, products, or tools that we provide, you understand and agree to accept and adhere to the following terms and conditions, including the privacy provisions in Section 6 (together, the "Terms of Service" or "Agreement").

This Agreement is effective as of January 1, 2026, and supersedes all prior versions.

We reserve the right to revise or change this Agreement from time to time at our sole discretion. If we make material changes, we will update the effective date above and, where appropriate, provide additional notice such as a website banner or email notification. It is your responsibility to periodically review this Agreement. Your continued use of the site after any modification constitutes your acceptance of the modified Terms.

This website is offered and available to users who are 18 years of age or older and reside in the United States or any of its territories or possessions. By using this website, you represent and warrant that you meet all of the foregoing eligibility requirements. If you do not meet these requirements, you must not access or use the website. Payment processing is handled by our third party payment processor, Stripe, Inc., and we do not store your full payment card number on our own servers. Stripe collects and processes your payment information subject to its own privacy policy, available at stripe.com/privacy, and in accordance with applicable card network and data security standards, including PCI DSS. We use the transaction information we receive from Stripe to fulfill your order, maintain business records, prevent fraud, and comply with tax and accounting obligations.

We do not currently use cookies, analytics, or advertising trackers. We anticipate adding one or more of these in the future, and when we do, we will update this section and provide notice as required by applicable law before that collection begins.

6.2 How We Use Information

We use the information we collect to operate and improve the website, respond to your inquiries, moderate user-submitted content, and comply with our legal obligations. We do not sell your personal information.

6.3 Your Privacy Rights

If you are a Colorado resident, the Colorado Privacy Act gives you the right to confirm whether we process your personal data, access that data, correct inaccuracies, request deletion, obtain a portable copy, and opt out of certain processing such as targeted advertising, the sale of personal data, or profiling. Residents of other states may have similar rights under their own applicable laws. We will respond within the time required by applicable law and may need to verify your identity before completing your request. We retain personal information only as long as reasonably necessary for the purposes described in this section or as required by law.

7. Indemnification

8. Dispute Resolution and Arbitration

8.1 Agreement to Arbitrate

You and The Natural Fox, LLC agree that any dispute, claim, or controversy arising out of or relating to this Agreement or your use of the website (a "Dispute") will be resolved by binding arbitration administered by the American Arbitration Association (AAA) under its Consumer Arbitration Rules then in effect, rather than in court, except that either party may bring an individual claim in small claims court if it qualifies. The arbitration will be conducted in Denver, Colorado, or another mutually agreed location, or, if both parties agree, by videoconference or based on written submissions.

8.2 Class Action Waiver

You and The Natural Fox, LLC agree that any arbitration or claim will be conducted on an individual basis and not as part of a class, consolidated, or representative action. The arbitrator may not consolidate more than one party's claims and may not otherwise preside over any form of a class or representative proceeding.

8.3 Right to Opt Out

You may opt out of this arbitration agreement by sending written notice to The Natural Fox, LLC, 8400 E Crescent Pkwy, Suite 600, Greenwood Village, CO 80111, within 30 days of the date you first accept this Agreement. Your notice must include your name and a clear statement that you wish to opt out of arbitration. If you opt out of arbitration, all other parts of this Agreement will continue to apply.

8.4 Exceptions

Notwithstanding the foregoing, either party may seek injunctive or other equitable relief in a court of competent jurisdiction to prevent actual or threatened infringement, misappropriation, or violation of a party's intellectual property rights.

9. Governing Law and Venue

All matters relating to the website and this Agreement, and any Dispute not subject to arbitration under Section 8, will be governed by and construed in accordance with the internal laws of the State of Colorado, without giving effect to any choice or conflict of law provision or rule. Any legal suit, action, or proceeding not subject to arbitration will be brought exclusively in the federal courts of the United States or the courts of the State of Colorado, located in the City and County of Denver. You waive any objection to the exercise of jurisdiction over you by such courts and to venue in such courts.
